PROPOSAL FOR CLASS RULES CHANGES

A. TO BECOME EFFECTIVE 2013

Adding sail battens in the jib leech

- 1) renumber G.4.1.4 and G.4.1.5 to G.4.1.5 and G.4.1.6 respectively
- 2) insert new G.4.1.4

The headsail shall have a maximum of three **batten pockets** in the **leech**.

- 3) add in new G.4.1.5
 - ..., batten pocket patches which may be made from a woven ply thinner than that of the body of the sail
- 4) add in G.4.2 Dimensions table

	Maximum
Batten pocket inside length	250 mm

B. TO BE INVESTIGATED, TO BECOME EFFECTIVE 2014 AT THE EARLIEST

Change the position of jib sheeting fairleads inboard, to reduce the need for windward sheeting

To be investigated upon approval of the 2012 General Assembly

Rule change proposal to be put up, after investigation, for the 2013 General Assembly

Old boats can be retrofitted with the proposed solution, which may include a simple aluminium bracket with a cleat and fairlead, positioned using old cleat holes
