420 International Class NOTICE OF RACE

The IV Semana Internacional de Vela Ciudad de Santander will be held, in Santander, Spain from 6th to 9th September 2018, by the Real Club Marítimo de Santander, in co-operation with the Spanish 420 National Class Association, the International 420 Class Association and under the auspices of Real Federación Española de Vela are pleased to invite 420 sailors to take part in this regatta.

1. RULES

- 1.1 The Championship will be governed by the Rules as defined in the WS Racing Rules of Sailing (RRS).
- 1.2 National Authority prescriptions will not apply.
- 1.3 Appendix P will apply
- 1.4 In all rules governing this championship:
- 1.4.1 [NP] denotes a rule that shall not be grounds for protests by a boat. This changes RRS 60.1(a).
- 1.4.2 [SP] denotes a rule which a standard penalty may be applied by the Race Committee without a hearing, or a discretionary penalty applied by the International Jury with a hearing. This changes RRS 63.1 and A5.
- 1.5 If there is a conflict between languages the English text will take precedence.

2. [DP][NP] ADVERTISING AND IDENTIFICATIONS

- 2.1 Boats may be required to display bow numbers and/or advertising chosen and supplied by the Organizing Authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.
- 2.2 Competitors ranking first, second and third in the series at the begiming of that day shall wear yellow, blue and red bibs while racing. The bibs will be provided by the Organizing Authority.

3. ELIGIBILITY

- 3.1 The Championship is open to boats of the 420 Class and to competitors who comply with WS Regulation 19 Eligibility.
- 3.2 Spanish competitors shall be in possession of the 2018 Spanish Licence card and each competitor shall be a member of his National Class Association.

4. ENTRY

- 4.1 All necessaryy information will be found in the on-line registration process at Regatta WebSite.
- 4.2 **The entry fee is free**. These entries include accommodation and all collective services provided by the organisation, such as social events, boat park facilities, toilets and showers.
- 4.3 The entry deadline is 1st August 2018 but the Organising Committee reserves the right to accept entries received after that date.
- 4.4 Support Team members (Coaches, team leaders and representatives from participating nations) are requested to fill in the entry form posted at Regatta WebSite.

5. FEES

5.1 Each competitor (and responsible adult if applicable) shall personally register and sign the registration at the Race Office, located near to the boat park, according to official schedule (see 7.PROGRAM). REGISTRATIONS WILL NOT BE ACCEPTED AFTER THIS TIMETABLE.

- 5.2 The following shall be presented by **competitors** upon registration at the race office:
 - 2018 Spanish Licence (only Spanish sailors)
 - Evidence of valid third party insurance
 - Proof of age
 - International 420 Measurement Certificate
 - Parental Permission Form for those under the age of 18
- 5.3 **Support personnel** may **register online** and the following shall be presented upon registration at the race office:
 - Boat Driving Licence (if applicable)
 - Evidence of valid third party insurance
 - 2018 Technical Spanish License (only for Spanish Coaches)

6. CHAMPIONSHIP FORMAT

6.1 All boats will race in a single fleet.

7. SCHEDULE

- 7.2 No warning signal will be given after 15:00 on the last day.
- 7.3 Nine races are schedules in the regatta and no more than three races shall be sailed each day.

8. [DP] [NP] MEASUREMENT

- 8.1 Each boat shall produce a valid Measurement Certificate, including the completed Measurement Form, at the time of pre-race measurement inspections. If the completed Measurement Form is a photocopy, its authenticity shall be confirmed with an original stamp and signature from the issuing authority. If boat is to produce a measurement certificate in accordance with RRS 78.2, she shall do so before 11:00 on 7th September 2018.
- 8.2 Event Measurement Regulations and Policies will be published on the Championship website before the start of the event and posted on the official notice board the day before the first day for event measurement. They will be available to competitors, team leaders and coaches at the Race Office upon request.

9. SAILING INSTRUCTIONS

9.1 Sailing Instructions will be available during registration at the Race Office and at the Championship website. Other documents governing the event will be published with the Sailing Instructions.

11. THE COURSES

11.1 The courses will be trapeziod. Target Time of racing 45'.

12. PENALTY SYSTEM

- 12.1 RRS Appendix P, Special Procedures for RRS 42, will apply.
- 12.2 RRS P2.3 will not apply and RRS P2.2 is changed so that it will apply to any penalty after the first one.

13. SCORING

- 13.1 The Low Point System of RRS Appendix A will apply.
- 13.2 Discards: When fewer than 4 races have been completed, a boat's series score is the total of her race scores. When 4 or more races have been completed, a boat's series score is the total of her race scores excluding her worst score.
- 13.3 One race is required to be completed to constitute a regatta.

14. [DP] [NP] SUPPORT TEAMS

- 14.1 All Support Team members shall be registered with the Organizing Authority (see 4.4 & 5.4) and will be required to comply with local legislation and event support team regulations. All boat drivers should have a valid Certificate of Competency of a seagoing vessel. The Organizing Authority may refuse registrations and accept later registrations at their sole discretion.
- 14.2 Registered Support Team boats shall act as assistance / rescue boats in case of need and shall comply with any instruction given by the Race Committee or the Organizing Authority.
- 14.3 All Support Team boats shall have third party liability insurance with a minimum cover of EUR 1.500.000 or equivalent per incident.

15. [DP] [NP] BERTHING

When berthed, boats shall be kept in their assigned place at the boat park

16. PRIZES AND TITLES

16.1 The first three crews in the ranking list, for each cathegory (Senior, U19, U17), shall be given a trophy. Also the first women crew in these cathegories.

17. RISK STATEMENT

DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The Organising Authority will accept no liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta. By taking part in the event, each competitor agrees and acknowledges that:

- 17.1 They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- 17.2 They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- 17.3 They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- 17.4 By participating in any race, they are satisfied that their boat is in good order, equipped to sail in the event and they are fit to participate;
- 17.5 The provision of a race management team, safety boats, judges and other officials and volunteers by the organizer does not relieve them of their own responsibilities;
- 17.6 The provision of safety boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.
- 17.7 They will familiarize themselves with any venue/event specific risks, adhere to rules and information produced for the venue/event and they will attend any venue/event safety briefings.

18. [DP] [NP] MEDIA RIGHTS, CAMERAS AND ELECTRONIC EQUIPMENT

- 18.1 By participating in the Championship competitors automatically grant to the Organizing Authority and their sponsors, the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the athlete during the penad of the competition without compensation.
- 18.2 Boats may be required to carry cameras, sound equipment or positioning equipment as specified by the Organizing Authority and in accordance with the relevant class rules.

19. INSURANCE

19.1 Each 'person in charge' (see RRS 46) shall hold a valid insurance certificate showing proof of third-party liability with a minimum coverage per incident of EUR 360.000 per event or equivalent. The Organizing Authority is not responsible for verifying the status or validity of such certificates.
