4. OTHER CONDITIONS

- 1. The Sailing Centre must provide a valid third party liability insurance for all the users of the centre.
- 2. The period of certification or renewal of certification of the 420 Sailing Centres is for 5 years.
- 3. The process of initial certification or renewal of certification of the 420 Sailing Centres requires an inspection of a nominated inspector appointed by the International 420 Class Association. The applicant Sailing Centre must pay the flight, accommodation and a per diem for meals (or provide meals) for the inspector.
- 4. The 420 Certified Sailing Centres will be published on a dedicated area of the International 420 Class Association website with links back to their respective website. Certified Sailing Centres must use the accreditation logo in a visible location on their website and link back to www.420sailing.org
- 5. Each 420 Sailing Centre will be provided with a 420 Flag, a Certificate of Accreditation and an Accreditation Plaque to be displayed at the centre and will be given the right to use the 420 Sailing Centre logo (to 420 Class brand guidelines).
- 6. The fee for certification of a 420 Sailing Centre will be €150 for a 5 year period.
