#### **EXECUTIVE COMMITTEE**

Under the Articles of Association, the President and Vice-President are due for (re-) election in 'odd' years. Nominations for election to the EC shall be submitted to the EC three months before the date of the General Assembly, i.e. 18<sup>th</sup> of April 2015.

#### **TECHNICAL COMMITTEE**

# **PROPOSAL FOR CLASS RULES CHANGES**

#### A. TO BECOME EFFECTIVE 2016

#### 1) change the introduction of Part II as follows:

The **crew** and the **boat** shall comply with the rules in Part II when *racing*. <u>The Notice of Race may</u> <u>specify that compliance shall be in effect from the moment equipment is presented for</u> <u>inspection</u>. Measurement to check conformity with rules of Section C is not part of **equipment certification measurement**. Measurement shall be carried out in accordance with the current version of ERS except where varied in this Part.


#### 2) renumber existing C.3.2 to C.3.2 (1) and then add new C.3.2 (2)

Electronic or mechanical timing devices which don't have any other function / capability. No other electrical or electronic device shall be carried on board.

#### 3) add new C.10.3.1.(e)

When required by a Notice of Race, a **skipper's** national flag, nominal size 740 x 443 mm, shall be applied to each side of the **mainsail**, placed as shown in the Figure "Mainsail Flag Location", so that the shortest distance of the upper aft corner of each flag is between 50 and 100 mm from the **leech** and the lower edge between 50 and 100 mm above the lowermost **batten pocket**. The flags shall be made by an ICA-approved manufacturer as listed at:
